Contractual Agreement

I, _____ am enrolling my child, _____ in Cassville Nursery. As such, I agree to abide by Cassville Nursery's policies and procedures. I also agree to the following terms and conditions.

My child will be attending the following days and hours: _____

As part of my child's enrollment I agree to pay a monthly fee of _____ and provide a deposit of _____. Checks should be addressed to "Cassville Nursery." I understand this is a guaranteed rate and includes full pay for holidays, with no credit for absent or sick days. Mid month enrollment will be pro-rated. This monthly fee is due by the last weekday of each month prior to attendance. I agree that if my payment should not occur on said dates, that I will be charged an extra \$10 for every day that I am late on payment.

There is a \$25.00 service charge on all returned checks. Should there be 2 returned checks within a six (6) month period, you must pay by cash or money order

This contract is in effect from the effective date shown at the beginning of this contract, until revoked in writing. This contract may be revoked at any time by either party in writing only, with a 2 week notification. Notification of withdrawal by a Parent/Guardian must be made to the Nursery School Director at Cassville Nursery. Your child is considered enrolled and you will be charged until written notice is given. The deposit will be returned upon withdrawal. Any outstanding fees, late fees and fines will be deducted from the deposit.

I agree not to park or pull my car over and stop on Route 571 in front of Cassville Nursery. Jackson Township has prohibited this.

Waiver and Release of Liability

I the undersigned, acknowledge and fully understand that each nursery school participant will be engaging in activities that involve risk of injury. I agree not to sue Cassville Nursery, or their teachers, assistants, or employees for any injury that may occur en route, during, or upon departure from the nursery school unless "gross negligence" is involved. I understand that by signing this waiver substantial rights have been given up and we, I sign it voluntarily. By signing below, I agree to the above terms and conditions.

Web/Photo/Video Release

Should pictures and/or video be taken at Cassville Nursery, I do hereby give permission for our/my children to be included in picture, likeness, image and/or voice in any videotape, website or publication promoting Cassville Nursery.
